RIGGER broke to front, responded to open clear advantage into stretch, went unchallenged, ridden out to wire. NORMANDY'S MAZE within striking distance from outset, came four wide into lane, no match for winner but gamely for second spot. PEACEFUL LOVER vied for lead on the outside of rivals from outset, came three wide into stretch, tired. TULSA COUNTY allowed to settle early, improved position. VELVET RAGE well back at the half, passed tiring foes in lane. B. DISTINCTIVE raced in middle of pack, failed to menace. ALYSSA'S SEMORAN stalked early pace, faded after quarter mile. C THE STORM chased pace for half, dropped back. DISTINCT SILENCE was outrun. METAL MUNCHER forwardly positioned for quarter mile, faded steadily thereafter.
