**Footnotes**

LOAN ME THE MONEY outrun for three quarters, advanced inside entering the second turn, split rivals upper stretch and steadily drew clear under steady urging. WOMAN OF CHOICE unhurried early while inside, inched closer up the backstretch, altered outside entering the stretch, responded when sat down for the drive and was just up for the place. SMART APPEAL dueled from the outside early, dueled up the backstretch with SPICED, put that one away entering the second turn, held a clear advantage at the eighth pole but could not last. DANDIONE chased the pace outside but had nothing left. CODED ACCOUNT well placed outside, had no late response. NETTIE'S PICK forced the early pace and tired. SPICED dueled from the inside and gave way.
