GRAND ALI chased pace along rail from outset, responded to handling to gain command into stretch, kept to task during run to wire and remained clear to wire. SULLEYMAN TIME came from middle of pack along inside when making bid into stretch, came to middle of lane in drive finished well but was not good enough but much best of others. GAME PATRIOT stalked leaders along inside into stretch, lacked rally. CAHILL well back early, came four wide into stretch, finished with a belated mid track rally. L L BIRDWELL broke alertly, dropped back while racing wide, lacked response when asked. ME 'N MY WILDCAT hustled to front, set pace into stretch, gave way. WAVERING SLEW failed to menace. BENCHIDY well back from start, never a factor. SOONER SUNSET wide of rivals from start, never a threat. KEAT KENNEDY forwardly positioned outside rivals for half, faded. ROYAL CAUSEWAY showed little. FAST TALKING CAT was outrun. IRISH YANK was never close. LIL GONE vied for early lead, stopped after quarter mile.
