OKIE RIDE stalked the early pace from the inside, inched closer entering the turn, altered outside for the drive and was along in time. APPREHENDER dueled from between foes for the early lead, remained engaged through the turn, battled through the drive but was outfinished. OKIE TUFF dueled from the outside for the early lead, battled through the turn, remained forward for the drive but could not keep pace. GOLD COYOTE outrun early, advanced outside entering the turn, responded and finished well but too late. RED COYOTE dueled from the outside but had nothing left. BID'S REWARD was no factor. FERDIE MAC was no threat.
