APPEALING VISION broke alertly to front, opened clear advantage into stretch, responded to mild urging, remained clear to wire. CALL POPPIE chased leader throughout to no avail and settle for second best. FINAL TOPPING was never far back, finished with a mild rail rally. SWISSE CHAI within striking distance along inside into stretch, had no rally. BETA BELIEVE in back at the half, lacked response when asked. TROPICAL DOLL forwardly positioned from start, came four wide into stretch, lacked response in drive. FIREWHIRL vied while racing between rivals for half, gave way. SOX ON A FOX was never a factor. ELIZABETH'S COLORS was outrun. RIO CATTY was never close.
