### Footnotes

BUTTERFLY PRINCESS allowed to settle early while not far back, moved up smartly along rail entering stretch, responded to steady urging in drive to gain nod mid stretch, then drew off while being kept to task. PORT OF TEXAS was never far back, commenced bid racing five wide into stretch, responded with a strong belated mid track rally. MACKEEES LAST TRICK stalked leaders on the outside from outset, came four wide into lane, moved up mid stretch to loom danger, flattened out. KISSES FOR NICKI chased pace for half, tired. LOVELY AVENUE sent to front, set pace for half, gave way. HEADED HOME failed to menace. SIOUX MIRAGE was never a factor. WITCH'S TWITCH never threatened.
