MY MISTY ROBIN stalked the early pace from the inside, inched closer entering the second turn, responded to gain the advantage and held sway. CLIFF'SNAUGHTYGIRL allowed to settle early, steadily advanced outside, responded when asked but could not reach the winner. FAVORABLE VERDICT broke sharp from between foes to gain a clear early margin, remained clear entering the second turn but could not keep pace. QUEST FOR JOY outrun early, advanced outside, responded and finished well. MIRACLE ON HIGH well placed from the inside, made a bid entering the second turn but could not sustain the effort. SULTRY GAL forced the early pace outside and tired. TAYLOR'S SWIFT chased the early pace outside and tired. JUMP DRIVE forced the early pace inside and tired. INDIGO JADE had a steady fade. DON'T FLATTER ME was no factor. BRIER HILL J J had little interest. CORRESPONDENCE showed little.
