(Maiden and Claiming races not considered in weight allowances). Starters to be named through the entry box by the usual time of entry. Trophy to the winning owner. Closed Friday, September 21 with (29) nominations.

STICKS WONDERGIRL broke sharp from the inside, dueled from the early lead, gained a clear margin up the backstretch, responded when challenged entering the drive, opened a clear margin at the eighth pole then was all out late to prevail. JEMIMA'S PEARL stalked the early pace from the outside, advanced entering the second turn, responded when sat down for the drive but was outfinished. YANKEE UNION dueled from the outside early, remained in a forward position up the backstretch, responded to challenge the leader entering the drive but could not match strides. LADY JENSEN up close early from the inside, remained forward for the drive but had no late response. YVETE SANGALO (MEX) was no real factor. BONNIE PARKER chased the early pace and tired. PEDESTRIAN showed little.
