Footnotes

GINGER BRICK ROAD well placed from the inside early, tracked the pace up the backstretch, reached a striking position entering the second turn, responded to duel through the drive and was along in time. GUANABARA GAL outrun early, advanced from between foes entering the second turn, altered outside for the drive and found her best stride too late. LESLEY BE JUDGED stalked the early pace from the outside, inched closer entering the second turn, responded but could not keep pace. INCLINED TO DREAM pressed the early pace from between foes, remained forward for the drive but was no match late. GRAND OPRY chased the early pace from between foes but could only improve position. BADGE OF GOLD broke sharp from the inside, gained a clear early margin, remained clear up the backstretch, held a forward position for the drive but tired. SEA OF DREAMS forced the early pace from the inside but had nothing left. JET'S ATTACK was no factor. ELEGANT AFFAIR chased the pace and tired. DIXIE TALE was never close. BIN QUIET showed little. CHARMEDBYTHEKING had a steady fade.
