REPOSITORY pressed the early pace outside, made a bid entering the stretch, duelled through the stretch but could not keep pace. WESTERN DELIGHT well placed inside, had no late response. STRAWBAILEY could only pass tired ones. GOLDEN HURRICANE quickly gained the early lead outside, set the early pace but tired. FRAZZLED was no factor. RED RIVER LADY chased the early pace outside and stopped. MANSTONE forwardly placed outside but gave way.
