MISS HOCKADAY was allowed to settle in stride for half, commenced bid circling rivals leaving far turn, came six wide into stretch, responded to urging in drive, got up and drew off in late going while racing mid track. FAVORABLE VERDICT broke to front along inside, set pace into stretch, went gamely under pressure but couldn't last. TALKING AUDREY allowed to settle in stride early, raced five wide into stretch when making bid, finished with a mild belated mid track rally. ELUSIVE ROSSI stalked leaders along inside from outset, moved up to be nearest pace mid stretch, gave way in late going. MYREDDOLLY saved ground while forwardly positioned into stretch, to no avail. SUBLIMATION wide of rivals from outset, failed to menace. ELIZABETH'S COLORS trailed for early, improved position. DREAM MARQUET was not a factor. BULLRUNNA raced along inside, never threatened. BETA BELIEVE chased pace for half, dropped back. SOX ON A FOX was through early, eased in lane, crossed finish. OSO FINE GAL was never close, broke down stretch.
