CAJUN PERSUASION broke to front, set pace with clear lead into stretch, responded to steady handling in drive and prevailed in the end. CASHINMYWRANGLERS chased leader from start, went gamely but to no avail. SMOKIN ARMADILLO was allowed to settle early, came four wide into stretch when making bid, lacked response when asked in drive. FIFTY FIVE SOUTH within striking distance into stretch, had no rally. MOMMA'S BADNEWS failed to menace. CHARLIE AND CHRIS was not a factor. HER MAN stalked leaders on the outside into stretch, gave way. DIAMOND BLADE raced in middle of pack into stretch, failed to threaten. BULLZABOY was always outrun.
