SHE'SGOTHEROWNJET broke on top, rated well with clear advantage into stretch, kept to task, remained clear to wire. CUVIER well back early, circled six wide into stretch, finished well with a belated mid track stretch rally. FOXIE AN FUN chased pace from outset, went game in drive before weakened in late going. JEB'S GIRL dropped to rail, moved up along rail into stretch, finished with a mild rail rally. RACE JUDICATA came five wide from middle of pack into stretch, failed to menace. FIREWHIRL stalked leaders to stretch, gave way. HAPPIER THAN THOU was not a factor. FRISKY'S SHADOW along inside forwardly positioned for quarter mile, gave way. SACRED NOTE never threatened. CINQ DU MAI was outrun. MY OL FLAME was never close.
