SOFIE'S PEARL was allowed to settle early while on rail, responded to steady urging in drive and got up for second spot in final stages. WHEN WE BELIEVE stalked leaders on the outside from start, moved up to loom danger mid stretch, flattened out. SORCHA trailed early, passed tiring foes. PURE DIVINITY hustled to front, set pace to stretch, gave way. YAYA J was not a factor. ALYSSA'S DREAM was never a threat. VANITY'S SHOWCASE chased pace for half, dropped back.
