Footnotes

TWO TIMIN SLEW far back early, advanced outside entering the turn, responded when asked entering the drive and was along in time. BULLCREEKROAD chased the early pace from the outside, inched closer entering the turn, dueled through the drive, gained a short advantage deep stretch but could not last. P L STOP LIGHT forced the early pace outside, made a bid entering the drive and finished well. SIR MIGHTAS dueled from the outside early, gained a clear margin entering the drive, was engaged through the stretch but could not keep pace. UNOME'S KANDIMAN could only improve position. SNOOPER forced the early pace outside and tired. HOODED THUNDER went evenly. KORONA KAT dueled from the inside and tired. TRULY TRULY TRULY pressed the early pace and tired. HOOCHIE KAMOOCHIE chased the early pace and tired. UNOME LODE was always outrun.
