### Footnotes

TANALIAN well placed from the inside, advanced entering the second turn, gained a short advantage at the eighth pole and was clear late while kept to task. CACTUS SON dueled from the inside for the early lead, remained engaged through the turn, remained forward for the drive but could not match strides. VALID MESSAGE outrun early, advanced outside entering the second turn, responded and was gaining late. INDEPENDENT GEORGE allowed to settle early, advanced entering the second turn, responded but was too late. EVADE forced the early pace outside and tired. SCRAPPY ROO was no factor. RED PETE chased the early pace outside and faded. REMUS dueled from the outside and gave way. SMOOTH SEA was finished early.
