Supplemental nomination of \$2,500 due Friday, October 19 (includes entry and to start fee). Weights: Three-year-olds 119lbs.; Older 123lbs. Non-winners of \$30,000 twice at one mile or over on the turf in 2007 allowed 2 lbs.; \$30,000 once at one mile or over on the turf in 2007 4 lbs.; \$18,000 at any distance in 2007, 6 lbs. (Maiden and Claiming Races not considered) Starters to be named through the entry box by usual time of entry. This race will be limited to 12 starters. Trophy to the winning Owner. (High Weights Preferred According To The Scale Of Weights, Total Earnings in 2006-2007 For Horses Assigned Equal Weights). Nominations Closed Friday, October 12, 2007 with (29) Nominations. (If management deems it necessary to take this race off the Turf, it will be run at a distance of 1 1/16 Mile on the main track.).

Footnotes

ASCERTAIN (IRE) chased leaders from outset, responded to steady urging to take clear advantage mid stretch, proved best in an all out effort to the wire. RED ROCK CREEK dropped to rail after break, worked way forward into stretch, responded with a late surge that just missed. SMOOTH BID within striking distance along inside from start, rallied while between foes in run to wire but fell short in a game effort. BREGO stalked leaders on the outside from outset, came three wide into stretch, moved nearest pace while racing mid track in stretch, weakened. ALMOST CERTAIN well back to stretch, finished with a mild inside rally. HABANEROS forwardly positioned outside rivals into stretch, lacked response. TRIAL BY JURY saved ground, failed to menace. NOTABLE OKIE was not a factor. WAUPACA showed little. SILVER HAZE never threatened. JONESBORO sent to front, set pace for three quarters, stopped.
