PLEASUREMAGHNET allowed to settle early, steadily advanced inside up the backstretch, altered outside entering the second turn, responded when asked to gain a clear margin at the eighth pole then was all out to last. WASP stalked the early pace from the inside, dropped back slightly up the backstretch, responded entering the drive along the rail and was getting to the winner. HASHA well placed from the inside, advanced entering the second turn, responded and was gaining late. NOBODYS BUFFOON forced the early pace from between foes, held a forward position for the drive but had no late response. DONI dueled from between foes and tired. WOOD BE LAWYER dueled from the inside and tired. CARE TO WIN was no factor. MR. GOLD BAR had little interest. FIN DOCTORE was never close. COOL CRYPTO dueled from the outside and tired.
