### Footnotes

WHITE CHIFFON dueled from the inside for the early lead, remained engaged through the turn, battled with DEMO SESSION through the drive and outfinished that one late. DEMO SESSION stalked the early pace from the outside, inched closer entering the turn, responded to duel with the winner but was outfinished. DREAM BELIEVER outrun early, advanced inside entering the turn, altered outside for the drive and was gaining late. STACKEDNDELIVERED chased the early pace from the inside, remained forward for the drive but could not keep pace. BETA BELIEVE could only improve position. HOWHI ISTHEWATER dueled from between foes and tired. SYLVAN SAINT dueled from the outside and faded in the drive. MOKALATA was finished early.
