VOLADORA unhurried early, advanced outside entering the second turn, altered outside upper stretch, responded to pressure to be unthreatened the final furlong. STORM ME SEPTEMBER outrun for six furlongs, rallied outside entering the stretch and was gaining late. BEAUTY RUNS quickly gained the advantage, set the pace up the backstretch, remained a threat entering the stretch but weakened the final eighth. LADY CHERYL forced the pace outside, bid entering the stretch but faltered late. UNBRIDLED EMOTION raced forwardly but had no late response. COCOA CREEK forwardly placed early, could only go evenly late. BLAZE N BOOTS was no threat. WIFE FOR LIFE forced the pace outside but tired in the drive. RUN FOR GOLD chased the early pace but stopped. DAZZLING DEBUT was finished after going a half. This race was hand timed.
