Footnotes

SETTLEMENT OFFER broke to front, opened clear advantage into stretch, kept to steady urging in lane while increasing margin to wire. STEPHENGOTHISSTAR well back early, swung four wide into stretch, no match for winner but got up for second spot racing mid track. SOL T DAWG dueled for early advantage, dropped back at the half while racing along rail, responded to handling and got up for show money. GOINS TO TOWN well back for half, came four wide into lane, failed to seriously menace in drive. BLAZEN SUMMER chased early pace along rail, gave way before half. PARADE ROUTE forwardly positioned along inside for half, gave way. MASTERSON chased pace to mid stretch along inside, faded. ECHOE DEAL forwardly positioned outside rivals from start, came three wide into stretch, faded. SCULPTED dueled while racing between foes for half, dropped back. CRANKY CAT was always outrun.
