### Footnotes

VENETI hustled to front, set pace to stretch, pressured in drive while racing between foes, responded with a late surge and got up final strides. DOC'S DELIGHT was never far back, came three wide into lane, responded with a strong rally between rivals in late going and was outfinished in a gallant effort. SAMBA G stalked leaders along rail from outset, rallied along rail in drive to wire, outnoddod on the wire in a blanket finish. COUPLE WHILES trailed for half, swung five wide into stretch, finished with a solid effort but too late. ON SAFARI well back after a half, came three wide into stretch, finished with a solid belated bid. OSWEGO raced in middle of pack along rail from outset, had no rally. SHMI SKYWALKER chased pace for three quarters, gave way. KISSMEPLEASE along rail and never a factor.
