MAGICAL GRACE dueled from the outside for the early lead, remained engaged through the turn, battled through the drive and inched clear late. SEVEN'S ROSE stalked the early pace from the outside, advanced entering the turn, responded when asked but could not reach the winner. R. V. INGWITH MARV dueled from between foes for the early lead, battled through the turn, remained engaged with the winner through the drive but could not keep pace. LOTTERY LASS well placed from the inside, remained forward for the drive, responded and finished well too late. FAITH RULES pressed the early pace inside but was no threat late. TETON FIRE could only improve position. TWICA could only pass tired ones. BORREGAN LASS was no factor. DIXIE WARRIOR was no threat. MELLE PASSUUM showed little. SEND ME A KISS dueled from the inside and gave way. DUKIRA was never close.
