Footnotes

PULPITARIAN was allowed to settle for half, commenced bid circling foes leaving far turn, came five wide into stretch, responded to gain narrow edge mid stretch, kept to strong handling and edged clear late. EIGHTY MILLION within striking distance from outset, came four wide into lane when making bid, engaged leader mid stretch, dueled to wire only to be outfinished. UNBRIDLED SHERIFF stalked leaders while on the outside from outset, moved up to loom danger mid stretch, went gamely before flattening out in late going. CACTUS SON well back from outset, swung five wide when making bid, finished with a solid belated mid track rally. RUNAWAY TO ME stalked leaders into stretch, had no rally. WILDCAT TRUST trailed for half, raced five wide into lane, failed to menace. SHINNERS PASS forwardly positioned into stretch, faded. STREAKING SILVER was not a factor. PACHECO chased pace from outset, responded to gain narrow advantage three quarter call, dropped back in lane. TRIJONIA'S STAR forwardly positioned from outset, moved up to loom danger into stretch, dropped back. CARE TO WIN was never a threat. MAGESTIC WILDCAT hustled to front, set pace for half, stopped in lane.
