QUATORZE KID up close early from the outside, dueled up the backstretch, remained engaged through the second turn, gained a clear margin at the eighth pole and was clear late while kept to task. ANNA'S STRAWBERRY well placed from the outside, dueled through the second turn, remained forward for the drive but could not match strides. JENNA'S REPLY stalked the early pace from the inside, advanced entering the second turn, responded and finished well. CABALLERVO unhurried early, advanced outside, responded and was gaining late. JURISDICTION could only improve position. Q P'S PONY PUPPY chased the early pace and tired. DOUBLELUCKYLIONEL was no factor. C THE STORM was never close. SNOWLEOPARD'SGROWL broke sharp from the outside, gained a clear early margin, dueled up the backstretch then tired. JED EYE JOE forced the early pace and tired. BROADWAY CRUISER had a steady fade. HEZAROYALPLEASURE was finished after going a half.
