ACE AND JIM within striking distance along rail from outset, responded to strong handling while hugging rail during stretch drive, prevailed in an all out effort. MCTALLAH hustled to front, set pace with narrow lead into stretch, went gamely under pressure in drive only to be outfinished in the end. CAPE SEATTLE stalked leaders from outset, three wide into stretch, moved up to engage leaders mid stretch, went gamely but unable to reach top pair. SIR MIGHTAS dueled while racing between rivals into stretch, went gamely before tiring in late going. CHAIRMAN'S POSSE well back early, moved up four wide into stretch, lacked need late response in drive. CHILE FRITO stalked leaders along inside into stretch, had no rally. HAYSZMOON failed to menace. EAGLE TWO HUNDRED racing along inside, not a factor. JUKEBOX JUNKIE was not a threat. PHILLED UP well back at the half, five wide into lane, showed little. WHIRLING CREST was outrun. THEY CALL ME EDNA was never close.
