XTRA SPICY broke sharp from the outside to duel for the early lead, gained a clear margin entering the turn, widen the effort at the eighth pole and was well clear while kept to task. LESSTALKLETSRUN pressed the early pace from the inside, inched closer entering the turn, responded but could only gain the place. MR. LAWTON chased the early pace from the inside, advanced entering the turn, responded but could not sustain the effort. VELVET RAGE forced the early pace from the outside, inched closer entering the turn and finished well. BAD MAN BROWN well placed from the outside, had nothing left for drive. NORMANDY'S MAZE chased the early pace and tired. JAZZY RAZOR could only pass tired ones. FASHION BOY pressed the early pace and tired. MIAMI DUDE was no factor. PATS WARRIOR was never close. BULLY PETE dueled from the inside and gave way.
