WILL HE THRILL ME dueled on the outside of rivals from outset, responded to strong handling throughout stretch drive, got up in final strides. KIPRUSOFF dueled along rail from outset, went gamely while under pressure throughout stretch drive, only to be outnodded in the end. JURISDICTION stalked leaders along inside, moved up to engage leaders mid stretch, went gamely before weakening in late going. QUATORZE KID well back at the half, came four wide when making bid into stretch, finished well with a belated mid track rally. POWER BALL SLEW raced in middle of pack along inside, railed to menace. FINANCIERO dueled while between rivals for half, gave way. BARZEN well back at half, failed to menace. HEAR THE STORY was never a factor. SEATTLE OU RIEN forwardly positioned while saving ground to no avail. CAPTURE MATTIE was not a threat. HONOR SUNDAY raced in middle of pack outside rivals for half, gave way. KAREN'S DIAMOND was always outrun.
