GHOSTLY APPEAL up close early from the inside, crept closer entering the turn, gained the margin entering the drive, opened a commanding advantage at the eighth pole and was well clear while under steady urging. STICKAWAWA outrun early, advanced outside entering the turn, responded when sat down for the drive and was just up for the place. SOONER SUPERSTAR broke sharp from the inside, gained a clear early margin, remained forward entering the turn but was outfinished for the place. ONE LAID BACK CAT chased the early pace from the outside, remained forward entering the drive but could not keep pace. CAT VANBLU went evenly. SIS BOOM BAH chased the early pace outside but had nothing left. SAINTLY ONE was no factor. SHEZAPEPPER was no threat. WITH A DANCE was never close. SUPER DELICIOUS had a steady fade. SHE IS FOR OU TOO showed little.
