**Footnotes**

FR. DENIS within striking distance along inside from outset, came around three wide of rivals into lane, responded to steady handling in drive and got up in final strides. ALMAGNUS was never far back, swung four wide into lane, responded to steady urging in drive and just missed in a game try. TWISTED JUSTICE within striking distance from outset along inside into lane, responded to urging, gained narrow edge mid stretch, went gamely to wire but couldn't last. THREECLOCKFRIDAY well back for half, commenced bid racing three wide into lane, finished with a solid belated mid track rally. SUPERSTONE chased pace along rail to top stretch, went gamely before tiring in late going. HOT CHOCOLATE stalked leaders along rail into stretch, lacked response. SUPER FLUKE saved ground while well back for half, came off rail four wide into lane, failed to menace. RISKY WEATHER hustled to front, set pace for three quarters, faded. PROUGH JOE was always outrun.
