SCOOTONOVER set the early pace, edged clear into the stretch, was challenged in the final sixteenth and held sway. KOUFAX was within striking distance early, moved up four wide in the turn, rallied through the stretch and was gaining. HOT FOR YOU was allowed to settle early, advanced between foes into the stretch, then flattened. NO MORE DAY'S forced the early pace, lost ground into the turn and came back with a mild bid. LADY ANNABELLA was off slow early, went four wide and placed a steady effort. GOLDEN PROSPECTOR sustained a brief bid down the backstretch along the inside then weakened. TEE ELL CEE TERAS was outrun early, went five wide and failed to menace. VOTE OFTEN raced mid pack off the inside and was not a factor. SANDIAS CHILE showed little in a dull effort. The rider of HOT FOR YOU claimed interference against the rider of SCOOTONOVER and after reviewing the films there was no change made.
