T. V. STEVIE was unhurried early racing five wide, rallied in the stretch angling in three wide and edged clear. PENALTY BOX set the early pace while saving ground, was challenged in mid stretch and gave way grudgingly. THAT'S WHO forced the early pace from between foes, then tired in the drive and was clearly the best of the rest. POPEYES TINSAILOR hesitated at the break to get away slowly, went six wide and gained ground steadily. DOCTOR SPENCER was off slow early and showed some interest late. ZENON'S STAR was forwardly placed early four wide then weakened. GHOST CRAFT raced mid pack saving ground and lacked a late response. B R SANDSTORM was never far back in the early going saving ground then gave way. LEA COUNTY stumbled at the start to get away slowly and was not a threat. N Y LEA COUNTY hesitated at the break to get away well behind the field and was not a factor. There was a Stewards Inquiry into the start and after reviewing the films there was no changes made.
