FOR TWO YEAR OLDS THAT WERE NOMINATED AND REMAIN ELIGIBLE FOR THE 2010 RAINBOW QUARTER HORSE

FUTURITY.(G1) WEIGHT: 120,LBS. All horses must enter for the trials on Saturday,July 3,2010 by 10:00 A.M. and pay the \$1200 entry fee, if they are to run in the trials. Late nominations of \$25,000 (includes all fees) will be accepted at time of entry into the trial. Those who want to remain eligible for the 2011 Rainbow Derby, but elect not to run in the 2010 Rainbow Futurity time trials may do so, if they are still eligible at time of entry into the time trials, by payingthe \$1,200 entry fee into the Rainbow Futurity time trials. The ten fastest times from the trials will qualify for the final. There will be no "Also Eligibles List" for the final. NOTE: All races this day will be trials. First post time may change due to the number of trials.
