A. P. FLATTER was allowed to settle early racing off the inside, loomed up three wide into the second turn, gained the advantage nearing the eighth pole and edged clear in the stretch. DE MY MAUREEN was void of early speed, showed a steady gain, went four wide with a late effort to gain the place. SNOWDROP was unhurried early racing off the rail, angled three wide to place a bid and gained the show. LITTLE MISS RULER was outrun early, rallied six wide through the stretch and lacked a gain late. SETUSTRAIT was off slow early, went six wide and passed tiring foes. LISIANSKI stalked the early leader racing off the inside, gained a short lead at the quarter pole then gave way in the stretch. CHERRY ONE tracked the early leaders while saving ground, angled out in the stretch and faded. ORABELL set the early pace drawing clear down the backstretch, was challenged into the second turn and retreated in the stretch.
