DONTCHACALLNOMO forced the early pace four wide, sustained a bid into the turn then edged clear in the stretch. DANDY ONE was within striking distance early along the rail, was forced to steady to avoid fallen foe nearing the five sixteenths then angled out three wide and closed. BROTHERTONE was hustled away along the inside, drifted out nearing the five sixteenths, then drifted out again at the sixteenths pole from left handed urging and weakened. CARSON LAKE was unhurried early three wide, was steadied nearing the five sixteenths then placed a mild gain. A. P. FOURELADY was outrun early, went four wide and was steadied nearing the five sixteenths to avoid foe then lacked a rally. LONG GONE BIRDIE was off slow early and failed to threaten. JR BEAN was void of early speed and was not a factor. GHOST REALMS forced the early pace from between rivals, clipped heels nearing the five sixteenths, then fell and unseated his rider. There was a Stewards Inquiry and after reviewing the films it was determined there would be no change.
