PLEA AGREEMENT was off slow early racing along the rail, angled out to split foes into the second turn, then loomed up four wide to be on even terms and finished well to prove best. SMOLDER was unhurried early saving ground, angled out five wide and showed some effort late to gain the place. R SKYDIVER was outrun early racing three wide, angled in to save ground, vied in the stretch then flattened. HOMETOWN WILLY was within striking distance early racing four wide, shuffled back into the second turn then passed tiring foes. SLEWYVILLE SLUGGER prompted the early pace from along the rail, dueled briefly then gave way. RUTHERFORD broke slow then moved up to draw clear into the first turn, dueled briefly then retreated in the lane.
