LAST MINUTE JOE was allowed to settle early, went five wide into the first turn, sustained a bid into the second turn, kicked clear into the stretch angling in to save ground and was much the best. SEA BATTLE set the early pace racing off the rail, was challenged into the second turn, failed to match strides, was no match late but held the place. TRISTANS SLEW broke sharply, dropped back along the inside, angled out four wide into the stretch and showed some effort late. JUMP WEST was forwardly placed early four wide between foes and lacked a late rally. SHAKIN N DANCIN was unhurried early, sustained a brief bid then gave way. BERMUDA SUNSET prompted the early pace from the inside and was finished early. DEVINE REVELATION was outrun early, went five wide and showed little. ROYAL JESTER trailed the field and was always outrun.
