Footnotes

SNOW RIDGE came in a bit just after the start, dueled between horses on the backstretch, was bumped between foes into the turn, took a short lead outside FREESPOOL nearing the quarter pole, kicked clear in the stretch and proved best under urging. EXPLICIT off a bit slowly and steadied when crowded, chased a bit off the rail, angled to the fence on the turn, remained inside, could not catch the winner but gamely took the place. RIO ORO forced the pace three deep between horses, was bumped and forced out into the turn, continued outside a rival on the bend and was narrowly edged for second. GIBSON COUNTY sent between horses early, vied for command four wide on the backstretch, was bumped, forced out and steadied into the turn, continued outside on the bend and could not recover. KINETIC BEND chased off the rail on the backstretch, steadied briefly into the turn, angled in on the bend and lacked the needed rally. UNBRIDLED TIME off a bit slowly, saved ground off the pace to the stretch, came out and was not a threat. FREESPOOL sped to the early lead, dueled inside, came out to bump the winner into the turn, battled inside that rival on the bend and had little left in the stretch. MISANELLO (CHI) wide early, raced close up tracking the pace five wide on the backstretch, steadied into the turn, dropped back and gave way. A claim of foul by the rider of EXPLICIT against the winner for alleged interference at the start was not allowed by the stewards, who ruled the minor incident did not warrant a disqualification.
