DIXIELAND BLUES saved ground chasing the pace, came out into the stretch, bid along the rail to take the lead, inched away in midstretch and won clear under some urging. MADEOFTHERIGHTSTUF stalked off the rail, bid three deep into the stretch, brushed with a rival in upper stretch and edged a foe for the place. ASHLEY'S BAMBINO broke slowly and was squeezed back, settled inside, came out into the stretch and again nearing midstretch and finished well. MY SLEW a bit slow to begin, saved ground chasing the pace, came out in the stretch and lacked the needed late kick. OUR LAST MONTE chased off the rail then outside, came out four wide into the stretch and lacked the needed rally. ELUSIVE JOURNEY settled outside then three deep, angled in alongside a rival on the hill and could not offer the necessary response. ALDADINO stalked outside then alongside a rival, came three deep into the stretch and lacked the needed rally. UNSTOPPER TOPPER dueled outside a rival, came out some in the stretch, brushed with a foe in upper stretch, was a bit crowded in midstretch and weakened. JOE DOGGS had good early speed and dueled inside, drifted off the rail in upper stretch and also weakened. LETHAL INTENT dropped back outside then off the rail, angled in on the hill, came out into the stretch and did not rally. ONEBADBOY pulled between horses early, chased off the rail then outside a rival, swung four wide into the stretch and lacked a further response, then did not return to be unsaddled when bleeding from the nostrils and was vanned off. SKULLY GULLY stalked the pace inside to the stretch and weakened, returned bleeding from the

nostrils but was walked off. Rail on hill at 14 feet.
