SMART LACY chased outside a rival, came out for room leaving the second turn and four wide into the stretch, battled three deep in midstretch, then pulled clear under urging. GOLDEN BAND dueled between horses early then angled in and battled along the rail, fought back through the stretch, could not match the winner late but edged a rival for second. QUE FACIL CORAZON had good early speed inside then stalked along the rail, bid three deep into the stretch, battled between rivals in midstretch, also could not match the winner late and just lost the place. MIDNITE MEETING pulled early, saved ground chasing the pace, inched forward leaving the second turn but lacked the needed response in the stretch. DONNA'S TOUR pulled her way along and was in a bit tight approaching the first turn, stalked outside a rival, swung four wide into the stretch and had no further response. BEL AIR BELLE unhurried along the inside early, dropped well back while saving ground and was outrun. STORMY SOCIETY four wide early, dueled three deep on the first turn then outside a rival, was between horses into the stretch and gave way.
