C. J.'S HONOUR had good early speed and dueled between horses, stalked between foes on the turn, came three deep into the stretch, bid outside the pacesetter and took the lead past the eighth pole, then pulled clear under urging. SEQUOIAN chased off the rail on the backstretch and outside on the turn, came four wide into the stretch and gained the place late. THROWIN HEAT off a bit awkwardly, went up between horses early then dueled inside but a bit off the rail, inched away on the turn, responded when challenged again, drifted in a bit in the stretch, could not match the winner and just lost second. TIMBER LEGEND had speed between horses then dueled three deep, stalked on the turn, came out into the stretch and was outfinished for a minor award. DISTINCTION chased inside, moved up along the rail on the turn, steadied in tight in midstretch, continued blocked along the rail, clipped heels approaching the sixteenth pole and could not recover. SEATTLE SHAMUS steadied early, lugged out off the rail on the backstretch, angled in for the turn, came out into the stretch and finished with some interest. KIRSCHWASSER saved ground off the pace, came a bit off the rail on the turn and passed tiring rivals in the lane. JUDGE OF CHARACTER had speed between horses early then stalked just off the inside, continued outside a rival on the turn and three deep into the stretch and lacked the needed rally. CHOGORI prompted the early pace five wide, stalked outside then dropped back on the turn and gave way and was eased in the stretch. TIMBER CRUISER chased outside, also fell back on the turn, gave way in the stretch and was eased. A claim of foul by the rider of DISTINCTION against THROWIN HEAT for alleged interference in deep stretch was not allowed by the stewards, who ruled the former never had sufficient room to go inside the latter.
