APPEALING RESUME saved ground chasing the pace, swung out leaving the turn and into the stretch, rallied under some urging to gain the lead in deep stretch and gamely prevailed. WOEBEGON had good early speed and set the pace a bit off the rail, dueled outside a rival leaving the backstretch and on the turn, inched away again in midstretch, fought back in deep stretch but could not quite match the winner late. WITH A MIRACLE stalked outside a rival then off the rail leaving the backstretch and on the turn, came out into the stretch was outfinished. MAGESTIC STINGER stalked inside then bid along the rail a half mile out, dueled inside on the turn and into the stretch and weakened.
