PEACE AND JUSTICE had speed outside a rival then inched away and angled in, set the pace inside, opened up in the stretch, drifted out some then lugged in a bit but won clear under a steady hand ride. BROTHER PETE drifted out some into the first turn, angled in and chased inside, split rivals into the second turn, found the rail into the stretch and just got the place inside. KESSABTSI had speed inside then saved ground stalking the pace, came a bit off the rail in the stretch and was edged late for second. JULES JOURNEY drifted out into the first turn then angled in and chased inside, steadied off heels into the second turn, swung out in the stretch and put in a late bid at a minor award. FOOTBRIDGE chased off the rail then outside a rival, came four wide into the stretch and lacked the needed late kick between foes. QUIET FORCE forced five wide into the first turn, chased outside a rival to the stretch, split foes past midstretch and was outfinished. MONEY CLIP broke a bit slowly, saved ground off the pace, split horses on the second turn, came three deep into the stretch and lacked the needed rally. U S CITIZEN pulled his way along inside to stalk the pace, continued along the rail on the backstretch, steadied in tight off heels into the second turn, remained inside could not offer the necessary response in the stretch. JONNY'S CHOICE three deep early, chased outside a rival on the backstretch and turn, came four wide into the stretch and did not rally. JUST FISHIN three wide into the first turn, stalked outside a rival, went three deep on the second turn and into the stretch and weakened. NO CONTINGENCY close up stalking the pace outside a rival to the stretch, dropped back in the drive and also weakened.
