Footnotes

ELLE DEHERE a bit slow into stride, came out early then chased inside or a bit off the rail, waited briefly off heels leaving the turn, angled out four wide into the stretch, bid outside foes past midstretch, came in and bumped the runner-up while taking the lead a sixteenth out and pulled clear under some left handed urging. GREAT BERNARDINE had speed off the rail then stalked outside a rival, bid three wide into and on the turn, dueled for the lead, gained a slim advantage in the stretch, drifted out a bit and bumped with the winner while between horses a sixteenth out and just held second. MARQUISITE stalked a bit off the rail, bid between horses into the turn to vie for command, fought back off the rail in the stretch, was crowded in a bit tight and steadied slightly a sixteenth out, had the rider lose the whip late and was edged for second. SCENT OF CHRISM chased outside then off the rail, angled in leaving the backstretch, went around a rival in midstretch and was outfinished along the inside for a minor award. WARREN'S GRANDSLAM a bit crowded after the start, was allowed to settle off the rail, came out in the stretch and was not a threat. WARRENS MATCHMAKER unhurried off the inside on the backstretch, went outside on the turn and four wide into the stretch and did not rally. SLEEPY TIME GIRL chased between horses then a bit off the rail, came out into the stretch and could not offer the necessary response. RIO'SFAVORITEONE bobbled at the start, chased outside then three deep, continued alongside a rival into the turn, came three wide into the stretch and weakened. SU SU SUSHI saved ground off the pace, came out from the rail in the stretch and failed to menace. UNUSUAL COUNTER a bit slow to begin, went up inside to gain the lead, set the pace along the rail, dueled into and on the turn, dropped back

into the stretch and weakened. The stewards conducted an inquiry into the bumping between the top pair in the stretch but made no change when they ruled both runners contributed to the contact between them and the incident did not alter the original order of finish.
