**Footnotes**

BUFFALO BIRD WOMAN dueled outside the runner-up throughout, drifted in some late to bump with that rival but gamely prevailed under urging. CONFOUND had good early speed and dueled inside the winner all the way, came out a bit in the final stages to bump with that rival and just missed. ONACCOUNTOFYOU took up sharply when squeezed at the start to drop well back, settled off the rail, came wide into the stretch and finished well. VIRIDIAN CITY stalked the pace outside on the backstretch and three deep on the turn and lacked the needed response. DONNA'S TOUR was sent inside early, came off the rail leaving the backstretch, angled back in chasing the leaders on the turn, swung out in midstretch and weakened. FLEET SPARROW broke outward, was not far back early when climbing on the backstretch, continued bit off the rail on the turn, came out for the stretch and lacked the needed rally. BLAIR'S FAVORITE chased the dueling leaders between horses to the stretch and weakened. HEAVENLY LADY broke outward and was wide early, continued four wide on the backstretch and into the turn, angled in some on the bend and gave way. The stewards conducted an inquiry into the bumping in late stretch but made no change when they ruled both runners contributed to the incident.
