FLASHMANS PAPERS (GB) chased outside then off the rail, came out in the stretch and rallied under some left handed urging and a vigorous hand ride to get up nearing the wire. CAPTAIN KALI had speed off the rail early, dueled three deep then outside a rival, inched away and drifted inward into the stretch, kicked clear but was caught late. REMUS a bit slow to begin, settled outside then off the rail, came out into the stretch and just got the show. POINT ATTENDED broke inward, went up inside then stalked off the rail, continued outside a rival leaving the hill, came out some in the stretch and just lost third. MENS HEAT dueled between horses then inside, came out when in a bit tight off the heels of the winner in upper stretch and weakened. TROPICAL HEAT settled off the rail then outside a rival, came three deep into the stretch and was not a threat. BRUSHBURN unhurried outside a rival then off the rail to the stretch, lacked the needed rally. DEVIL CAT M D saved ground off the pace, came out in upper stretch and failed to menace. PICK TO CLICK chased a bit off the rail or outside a rival, dropped back leaving the hill and weakened. PRAY FOR ACTION went up inside to duel for the lead, stalked leaving the hill and had little left for the stretch. Rail on hill at 7 feet.
