Footnotes

SEA OF SHOWERS a bit slow to begin, angled in and settled off the inside, went between horses leaving the backstretch, continued three deep on the second turn and five wide into the stretch and rallied under some urging to prove best. REVENANTE angled in and settled a bit off the rail, went outside a rival approaching the second turn, swung four wide into the stretch, bid five wide in midstretch, put a head in front but could not hold off the winner. NANOGRAM saved ground chasing the pace, came out into the stretch, bid between foes in midstretch and bested the others. CONSIGNADA (CHI) pulled early and was forced out into the first turn, stalked off the rail, bid three deep into the stretch and between horses in midstretch and was outkicked to the wire. ONACCOUNTOFYOU settled outside a rival, went up three deep on the second turn and four wide into the stretch and could not summon the needed late kick. SWEEP THE DECK pulled her way between horses early, angled in and set a pressured pace inside, fought back on the second turn and to midstretch then weakened some in the final furlong. FAIR BIANCA also pulled early, came out into the first turn, prompted the pace outside a rival, was between horses in midstretch and also weakened. INNOCENT KISS (BRZ) also pulled early, chased outside a rival, split horses into the second turn and did not rally. SENORA POPPY was in a good position chasing the leaders inside and lacked a response in the stretch. COCONUT GIRL flipped in the gate and unseated the rider before the start, was reloaded, had her head turn and broke slowly, trailed off the rail, angled in on the second turn and was outrun.
