Footnotes

CONGOR BAY stalked a bit off the rail then inside on the turn, came out and waited off heels into the stretch, split rivals in deep stretch to gain the lead and gamely prevailed under urging. POINT ATTENDED chased between foes then off the rail, went outside on the turn and three deep into the stretch and finished well. CUT THE CHECK had good early speed and dueled outside a rival, put a head in front into the stretch, fought back a bit off the rail in deep stretch and held third. ARASHI CAT stalked three deep between foes to the stretch, bid outside a rival in the drive and continued willingly between horses late but was outfinished. VENTANA a bit slow to begin, pulled his way along inside, steadied sharply in tight into the turn, came out in upper stretch, was boxed in between and behind rivals in midstretch, angled in off heels twice in deep stretch and continued on well inside late. FLASHMANS PAPERS (GB) dueled inside, fought back on the turn and into the stretch, then weakened. COMIC CLUB chased between horses, fell back nearing the turn, split horses early on the turn, angled to the inside in the stretch and also weakened. PRINCEANDREW broke in the air, was in a good position stalking the pace four wide to the stretch and had little left in the drive. A claim of foul by the rider of VENTANA against the winner for alleged interference into the turn was not allowed by the stewards, who ruled the former attempted to enter a spot where there was no clearance and was the cause of his own trouble.
