Footnotes

JAWS N' PAWS tracked leaders while four wide, advanced and challenged four deep entering the stretch, reached the front then edged away and safely held under urging. LINE ONE settled off the leaders while gradually angling over, stalked from along the rail early on the turn, swung back out three wide then rallied strongly under left hand urging and gained the place. CLASSY ATTRACTION bumped at the start, forced the pace while three wide then engaged leaders while three abreast on the turn, briefly battled inside winner in upper stretch, lost contact later in the drive and lost second late. BUTCH MARINO saved ground chasing the leaders into the stretch, shifted out in upper stretch and went willingly to the wire. YOU CAN DREAM was sent up along the rail and set pace into and on the turn, relinquished control into the lane, came out some and weakened. RUSSIAN RIVER was slow to begin, chased from along the rail, later came off the fence and improved placing in the stretch. SUBPOENA THE DRESS was also off bit slow, chased while three then four wide into the stretch and lacked any late response. FOR YOU MY HEART broke out and bumped rival, forced the pace from between horses, bit two wide and between on the turn but lost contact in upper stretch and yielded. VICTORY WITH CLASS reserved early, shifted over, saved ground into the

stretch and was outrun. DUBAI MACAU GIRL stumbled leaving the gate, chased while outside foe then four wide into the stretch and lacked any rally.
