**Footnotes**

TERROPLANE (FR) settled inside then a bit off the rail, came out on the second turn and three deep into the stretch and closed gamely under left handed urging to get up late. UNCLE DENNY angled in and set the pace outside a rival then a bit off the rail, drifted in a bit in midstretch then was taken out and held on gamely but was caught between foes late. GERONIMO (CHI) had speed inside then stalked the winner along the rail, bid from the fence in the stretch, got through and continued willingly. CAPITANO pulled a bit along the inside early, came just off the rail on the backstretch, advanced three deep into and on the second turn and into the stretch but could not sustain the bid in the final furlong. FAST AND FURIOUS (FR) three deep into the first turn, stalked outside a rival, moved up between horses on the second turn and into the stretch and was outfinished. CLIPPERDOWN (IRE) chased outside a rival, came three deep into the stretch and could not summon the necessary response. DEL MAR SHOW stalked outside a rival then inside on the second turn and lacked a response in the stretch. CRYSTAL CASTLE chased inside then between foes on the backstretch, continued just off the rail on the second turn and did not rally. TOBE SUAVE close up stalking the pace inside early, dropped back on the backstretch and weakened. RHYTHM MAD (FR) squeezed a bit just after the start, settled off the rail then outside a rival leaving the second turn and failed to menace. A claim of foul by the rider of GERONIMO against the runner-up for alleged interference in midstretch was not allowed by the stewards, who ruled there was room for the former at that point.
